Golf Reservation System:

1. Guaranteed starting times on the Quinta do Lago golf course are allocated to members according to their day of arrival or the villa they are occupying at Four Seasons Country Club.

The times allocated to the club are 15 times counting from the first time in the morning (7.30ish) and 8 times at approximately midday. At periods when all the times are not required the club will release those that it does not require. This is done at six months and at one month prior to the month of play. To maintain, as far as possible, the first and second hour periods in the morning this will be done by retaining the times from the first time in the morning counting forwards and the last time in the morning counting backwards i.e. the times in the middle will be released. For the midday period times are released maintaining one block of times only.

Thursday arrival villas (63 to 96) = allocated golf on Saturday/ Sunday

Saturday arrival villas (1 to 28) = allocated golf on Monday/ Thursday

Sunday arrival villas (29 to 62) = allocated golf on Tuesday/ Friday.

Golf planners are sent with the welcome letters to members 13 weeks in advance of the arrival date and we would ask that members advise us of their golfing requirements as soon as possible.

- Golf for allocated days will be booked on a first come first served basis.
- Non-allocated days will be released from 8 weeks prior to the first day of the month of play.
- Offsite members are able to book from 6 weeks prior to the 1st day of the month of play.

2. Whenever possible, allocation of times will be based on members' preference for 1st, 2nd hour or p.m. times.
3. Each Wednesday has been set aside for the Single Stableford Competition, giving full stroke allowance, followed by dinner in the evening. This is a package price and is not sold separately. Members who do not attend the prize giving dinner will not be eligible for a prize. All scorecards must be handed in before 19.00 hrs in the sports office.
 - Times for the competition are drawn. If you should have a preference for earlier or later times please let us know and we will do our best to accommodate you, if possible.
4. Members` wishing to play 'non-competition' golf on Wednesday may put their names on a waiting list. Any times available which are not used in the competition will be released for normal 18 holes in order of names on the waiting list.
5. Times are also available for 9 holes in the late afternoon. The times are at a discounted rate and should be booked on the day of play (at certain times of the year times may be booked the day before).
6. Members still have the opportunity to reserve golf in the usual way on their non-allocated days (see rules). In addition, for a nominal charge, members may reserve tee-times on other courses in the Algarve.

7. All bookings for golf may only be made either by e-mail, fax, written letter or golf planner. No golf bookings are accepted via telephone.
8. All members of the Four Seasons Country Club have a 25% discount on buggies, electric trolleys and pull trolleys on the Quinta do Lago golf course.

Rules for Golf reservations:

1. To play golf on all the courses in the Algarve, members are asked to produce their current golf handicap certificate.
2. Priority for golf on Quinta do Lago is given to members in residence.
3. Payment for pre-booked golf must be made immediately on arrival.
4. Green fees for allocated days must be paid by 12.00 hrs before the day of play.
5. Non-allocated days will be released to members staying at the club 8 weeks in advance of the 1st day of the month of play.
6. Golf booking cancellations must be made by 17.00 hrs two days in advance for Quinta North or South or members will be responsible for bookings made (i.e. bookings for Friday must be cancelled by 17.00 hrs Wednesday).
7. Members are requested to always collect their tickets in advance of play. If times are booked and tickets have not been collected by 18.00 hrs the day before play, the tickets will be left at reception and charged to the villa account.
8. Unless the golf course declares itself closed, refunds for bad weather cannot be given.
9. Cancellations for golf bookings made on outside courses such as: Vilamoura, Vila Sol, Pinheiros Altos etc. can only be made with golf course authorization or within the golf courses release period.
10. Non-resident members may book golf 6 weeks in advance of the 1st day of the month of play. Credit card detail will be required to guarantee the booking.
11. Visitors renting a villa at the Four Seasons Country Club are eligible for full owners' privileges during their stay.
12. Four Seasons Country Club membership cards must be produced when making golf reservations or collecting tickets.
13. Payment for Four Seasons Country Club golf green fees may be made as follows in the sports office:
 - Cash payment,
 - Charged to the villa number,
 - Credit card - Visa, MasterCard or American Express.
 - If you are a non-resident member, you may open a folio at reception and charge your golf to your folio account.
14. For personal reference, members are advised to keep a copy of the golf bookings made with the sports office and to check all bookings made on their day of arrival.
15. At the discretion of the club, some rules governing golf reservations may be relaxed during the quieter periods.
16. To benefit from the FSCC special rate all bookings on Quinta do Lago North or Quinta do Lago South must be made at the sports office.
